We are excited to finally turn this important corner in our community's response to the COVID-19 pandemic. As of January 13, per the announcement of Governor Gavin Newsom, California is currently in Phase 1B of COVID vaccine distribution. Appropriate healthcare, education, childcare, emergency services, and food and agriculture workers, and those age 65 and over can register for vaccination through their county's website.

While this is welcomed news, **each county is on their own schedule of vaccine distribution and it may take some time to transition from Phase 1A to different tiers of Phase 1B.** Please refer to your local county public health website via one of the links below to find when and where the vaccine is being administered for the various phases as outlined by the CDC. Registration and an appointment will be required.

California Vaccine Distribution Phases

Phase 1A

- Healthcare workers
- Long-term care residents

See [CDPH Allocation Guidelines for Phase 1a](#)

Phase 1B – Tier 1

- Individuals 75 and older
- Those at risk of exposure at work in the following sectors:
 - Education
 - Childcare
 - Emergency services
 - Food and agriculture

Phase 1B – Tier 2

- Individuals 65 -74 years of age
- Those at risk of exposure at work in the following sectors:
 - Transportation and logistics
 - Industrial, commercial, residential, and sheltering facilities and services
 - Critical manufacturing
- Congregate settings with outbreak risk:
 - Incarcerated
 - Homeless
