#### **COVID-19 Vaccine Dissemination**

The COVID-19 vaccine was administered to some frontline healthcare workers through hospitals and other designated facilities, as coordinated through the respective county public health agencies throughout California. This is now expanding to other essential workers and others in the 1b phase.

Some counties have begun setting up Super Point-of-Dispensing (POD) sites, like Dodger Stadium in Los Angeles, Long Beach Convention Center, Disneyland Resort in Anaheim and Petco Park in San Diego to name a few.

Please refer to your local county public health website to find when and where the vaccine is being administered for the various phases as outlined by the CDC. Registration and an appointment will be required. Encourage members to do the same.

# Prospective providers interested in enrolling in the California COVID-19 Vaccination Program to become a "vaccinator".

Program participating to disseminate vaccines is tightly controlled by the California Department of Public Health through the California COVID-19 Vaccination Program. *Prospect Medical is not an authorized "vaccinator" for members or contracted providers.* If you are interested in becoming a vaccinator in the program, please review the information below.

#### Who is Eligible to participate in the California COVID-19 Vaccination Program?

Currently, providers can enroll if they are:

- 1. a site that has received an invitation code from their Local Health Department OR
- 2. a General Acute Care Hospital invited by the California Department of Public Health to participate.

As the vaccine supply increases, additional providers will be able to enroll. More information will be shared when enrollment is expanded.

If you are interested in becoming a vaccinator for the California COVID-19 Vaccination Program, you must follow the steps provided on <a href="https://calvax.cdph.ca.gov">https://calvax.cdph.ca.gov</a>.

- Step 1 Enroll in Immunization Information System (ISS) Register for CAIR
- Step 2 View Storage Equipment Guidelines
- Step 3 View Enrollment Worksheet
- Step 4 Notify Contacts Identify key roles
- Step 5 Review Job Aids
- Step 6 Train Your Staff
