

Prenatal & Postpartum Care

Description: Deliveries of live births on or between October 8th of the year before the measurement year and October 7th with assessments of prenatal and postpartum care.

- **Timeliness of Prenatal Care:** The percentage of deliveries that received a prenatal care visit in the first trimester, on or before the start date or within 42 days of enrollment in the organization
- **Postpartum Care:** The percentage of deliveries that had a postpartum visit on or between 7 and 84 days after delivery

Service Required for Compliance:

Prenatal Care

Must be seen during the first trimester, on or before the enrollment start date or within 42 days of enrollment.

Must include a note indicating the date when the prenatal care visit occurred and evidence of one of the following:

- **A diagnosis of pregnancy; for example:**
 - Documentation in a standardized prenatal flow sheet, or
 - Documentation of last menstrual period (LMP), estimated due date (EDD) or gestational age, or
 - A positive pregnancy test result, or
 - Documentation of gravidity and parity, or
 - Documentation of complete obstetrical history
- **Documentation of prenatal risk assessment and counseling/education:**
 - Basic physical obstetrical examination that includes auscultation for fetal heart tone
 - Pelvic exam with obstetric observations, or measurement of fundus height (a standardized prenatal flow sheet may be used)
 - Evidence that a prenatal care procedure was performed
 - Documentation of LMP or EDD in conjunction with either of the following:
 - Prenatal risk assessment and counseling/education
 - Complete obstetrical history

Postpartum Care

Postpartum visit to an OB/GYN practitioner or midwife, family practitioner or other PCP on or between 7 and 84 days after delivery.

- **Must include a note indicating the date when a postpartum visit occurred and one of the following:**
 - Pelvic exam
 - Evaluation of weight, BP, breasts, and abdomen: Notation of “breastfeeding” is acceptable for the “evaluation of breasts” component.
 - The notation of “abdominal wound healing” is acceptable for abdominal assessment
- **Notation of postpartum care including but not limited to:**
 - PP care, PP check, 6-week check
 - Preprinted “Postpartum Care” form in which information was documented during the visit
- **Perineal or cesarean incision/wound check**
- **Screening for depression, anxiety, tobacco use, substance use disorder, or preexisting mental health disorders**
- **Glucose screening for women with diabetes**
- **Documentation of any of the following topics:**
 - Infant care or breastfeeding
 - Resumption of intercourse, birth spacing, or family planning
 - Sleep/fatigue
 - Resumption of physical activity and attainment of healthy weight
